Enhancements For Workflow Validation Rules

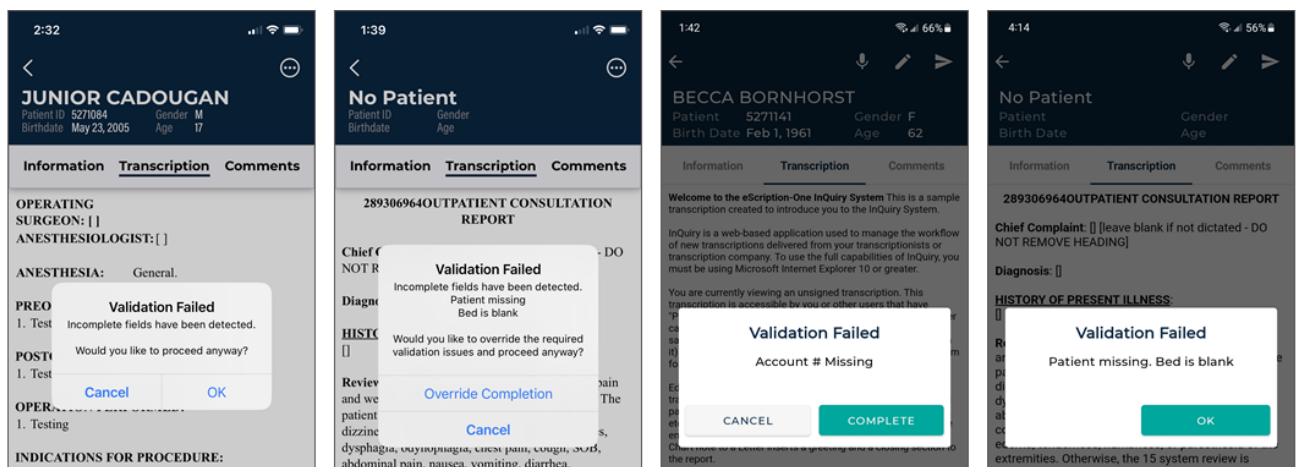
What's New?

DeliverHealth is pleased to announce the release of enhancements to the eScript One Mobile apps (Android and iOS) to further support workflow validation rules with detailed rule failure messages and additional logging.

Enhanced Validation Rule Messaging

In the past when validation rules were configured, the mobile apps would display a general message indicating some editing was needed before a transcription could be completed. This enhancement improves the message and adds additional functionality.

When a validation rule is triggered, a message displaying all failed snippets will appear. If the rule is a warning, users have the option to complete the transcription without first making edits. If the rule prevents completion, users need to edit the transcription and/or demographics before completing the transcription. If the user has the new Override Preventions role, they have the option to override the prevention of completion.

When a validation rule warning is given and the user completes without making edits, or a validation rule prevention is overridden by a user with the Override Preventions role, that activity is captured in the Transcription Information Activity Log.

The activity log entry can be expanded to view the name of the triggered validation rule, the rule completion option (warning or completion prevention), and the snippet that failed validation.

Minimum Application Requirements

Android

- eScription One Mobile for Android requires an Android operating system that still receives security updates from Android. As of 6/27/2022, version 10 or higher of the Android operating system is required. Open 'Settings' and tap 'About Phone' then 'Software Information' to confirm that the 'Android Version' or 'Firmware Version' listed is 10 or higher.
- Internet Access through a wireless Local Area Network (LAN) connection or through a phone service provider. It is strongly recommended to use a Wi-Fi LAN connection when uploading dictations. Minimum bandwidth: LTE/4G data connection; stable Wi-Fi with 3 Mbps download/1 Mbps upload or greater is recommended.
- A microphone for dictating is needed.
- Communicates over port 443 to <https://mobile.escription-one.com> using TLS 1.2.

iOS

- Any iOS device with iOS 15.2 or greater. Open 'Settings' and tap 'About' then 'Software Version' to confirm that the OS installed is version 15.2+.
- Internet Access through a wireless Local Area Network (LAN) connection or through a phone service provider. It is strongly recommended to use a Wi-Fi LAN connection when uploading dictations. Minimum bandwidth: LTE/4G data connection; recommended is stable Wi-Fi.
- Communicates over port 443 to <https://mobile.escription-one.com> using TLS 1.2.
